In the matter of the application for the incorporation of a Village in the County of Green and State of Wisconsin to be known as the Village of Monticello.

The above matter having this day come on to be heard before the Court at the March 1891 Term thereof for the County of Green at the Court House in the City of Monroe, in said County, upon the application by petition of five tax payers and residents of the territory of the proposed Village as hereinafter described, setting forth among other things the boundaries, courses & distance the quantity of land embraced, the resident population therein, according to the census thereof, and a survey map and census duly verified as required by law, and an affidavit that they were left & kept subject to an examination at the resident & place of business of a resident of said territory as provided by law, and a copy of notice of said application to gether with the proof of the publication thereof in the Monticello News a newspaper printed and published in said proposed terri tory as required by law, and a hearing thereon having been duly had in Open Court, A. S. Douglas appearing in behalf of said petitioners and no one appearing in apposition thereto, and it appearing to the satisfaction of the Court that a correct survey and map of the territory to be embraced within the limits of said proposed Village, showing the courses and distances of the boundaries thereof was duly made and verified as required by law that an accurate census of the resident population of the territory embraced in said proposed Village has been taken as required by law exhibiting the name of every head of family and the name of every person resident in good faith of said territory on the 6th day of January 1891, and the lots or quarter sections of land in which he resides, which census is duly verified by

said survey map and census when completed and verified as aforesaid were left at the post office the same being the resident & place of business of E. F. Wright within the territoty of said proposed Village and there kept subject to examination at all reasonable hours by every person interested for the full period of five weeks from the date of the first publication of the notice of this application, and that said gave due notice as required by law that they would apply to the Ci rouit Court for Green County on the 10th day of March 1891 for an order and decree incorporating the territory therein described and hereinafter described as a Village by the name of the "Village of Monticello" which notice described the boundaries by courses and distances specifying the town in which said territory lay and stating where the survey, map & census aforesaid have been left; and might be examined and that said notice was given as aforesaid by the publication thereof in said newspaper, the Monticello News a weekly newspaper printed & published in said proposed territory, for six consecutive weeks prior to said 10th day of March A. D. 1891, and the Court being now fully advised & satisfied of the correctness of the aforesaid survey map and census and that all the requirements of the statutes have been complied with, and that the lands embraced in said territory ought justly to be included in the proposed village, that the interests of the inhabitants will be promoted by such incorporation and that such territory included at the time such census were taken the population in number & in proportion to the quantity of land therein as provided in section 854 of the Revised Statutes and the acts Amendatory thereto.

Now therefore on motion of A.S. Douglas attorney for said applicants it is Ordered and Decreed, that the terri tory three described as follows to wit:\* "Commencing at a point twenty chains south of the north quarter post of Section No eighteen (18) in township No three (3) range eight (8) east in said County of Green, thence east seventy one (71) chains, thence north eighty (80) chains, thence west

(9) chains to the place of beginning, containing one square mile and being in the Town of Mount Pleasant in said County of Green and State of Wisconsin, shall be an incorporated village under the name of this "Village of Monticello", if the electors therein shall assent thereto as provided in Chapter 40 of the Revised Statutes of the Statutes of Wisconsin, and the acts amendatory thereto, and it is hereby further ordered that Orrin Bacon, E. F. Wright and J. C. Steinman residents of the said town of Mount Pleasant and within the limits of the above described territory be and they are hereby appointed inspectors and directed to perform the duties of Inspectors of election as required of inspectors and provided by said Chapter 40 of the Revised Statutes of the State of Wisconsin.
